### Cummins India Limited results for Q1 2009–10

**Pune; July 29, 2009:** The Board of Directors of Cummins India Limited, in their meeting held today took on record the unaudited financial results for the quarter ended June 30, 2009.

The published results of the Company for the quarter ended June 30, 2009 include the results of the erstwhile Cummins Sales and Service India Limited (CSS), a wholly owned subsidiary which merged with the Company during the fourth quarter of the preceding financial year 2008-09, with effect from the appointed date of April 01, 2008.

Net sales of the Company (including CSS) for the quarter ended June 30, 2009 stood at Rs. 625.6 crores, and the net profit before tax was Rs. 124.6 crores.

Net sales of the Company (excluding CSS), for the quarter ended June 30, 2009 stood at Rs. 506.9 crores, a decline of 28.3% from Rs. 707.0 crores during the same period last year, and a 17.5% decline from Rs. 614.7 crores in the previous quarter. Similarly, the net profit before tax in the first quarter was down by 22.5% to Rs. 93.7 crores compared to Rs.121 crores in the same period last year, but grew by 3.6% as compared to Rs. 90.5 crores in the January – March '09 quarter.

CIL results (excluding CSS) were impacted by lower export revenues at Rs. 93.7 crores during the quarter, compared to Rs. 277.9 crores during the corresponding quarter of the previous year, while domestic revenues were relatively less impacted with revenues at Rs. 413.2 crores, declining by only Rs.16.0 crores compared to corresponding quarter of the previous year. However, compared to the previous sequential quarter ended March 31 2009, domestic revenues grew by Rs. 103.8 crores (34% growth), whereas export revenues were lower by Rs. 211.6 crores.

**Anant Talaulicar, Chairman & Managing Director, Cummins India Limited** said, "We feel good about our bottom line performance which has improved as compared to the previous quarter even excluding CSS, despite a Rs. 108 cr. reduction in the top line. This was possible due to very strong cost management and a revival in the domestic markets. However, the global slowdown has impacted results and we do not see any signs of revival in this area in the short term. However, we



are not concerned as we are strongly positioned to weather this downturn as you can see from our results, and have in fact, improved our operating margins, and generated significant cash flow during the quarter. We are continuing to invest in new product programs and are positioning ourselves to emerge stronger when the global economy revives. The Company remains committed to delivering on its Brand Promise of Dependability.”
